Monday, May 20, 2024, Zoom meeting

**Treasurer's Report:** Jim Van Kirk reported the Foundation report is unchanged from last month. Next month's report should indicate that all underutilized funds will have expenses that will remove the "underutilized" label. The budget identifies a current "carry-forward" amount of over \$58,000 for the year. This amount will be reduced significantly after all end of year invoices are paid.

Patricia Saldana and Nancy Mitchell presented a marketing report indicating targeted markets for 2024-2025. Based on a survey asking how members got their news, OLLI will utilize funds to use facebook, radio, television, and print media to promote the organization and events. In addition to Lincoln and Omaha, OLLI will also target the I80 corridor across the state.

**Chair's Comments:** Helen reported this is her last meeting as council chair and thanked the council for their support. She shared key accomplishments the council reached during that time: a major revision of Policies and Procedures, membership growth, and financial stability

**Director's Report**: Bob Michl reported the OLLI staff will have a half day retreat at the end of May to discuss plans for the upcoming year. The Omaha Showcase will be on July 25 from 8:30-12:00 at the Scott Center in Omaha. The Lincoln open-house will be August 9th from 12:30-3:30 at the Great Plains ballroom on Lincoln's East Campus.

The 2024-2025 operating budget was unanimously approved.
